### The Product

FreeCap's flagship product is focused on criminal justice ratings and data. We are on a mission to defund the prison industrial complex and channel investment into companies that support formerly incarcerated workers. FreeCap's ratings define leadership criteria for how companies can be allies to currently and formerly incarcerated workers—and gives investors the transparency they need to make informed investment decisions. Our research team monitors companies' participation in the US prison-industrial complex and rates the ways they positively or negatively contribute to mass incarceration.

### The Position

FreeCap Financial is looking for someone to join the team as a Research Intern. The Research Intern will join our team in leading FreeCap's data collection and report to our Senior Research Analyst. The ideal candidate for this position is curious, analytical, and detail oriented. As an intern with FreeCap, this person will play a huge role in growing FreeCap's core product offering. As a Research Intern, you will be responsible for:

- Analyzing your ratings, using FreeCap's weighting system to score companies on how they are related to the prison-industrial complex.
- Reporting to the Senior Research Analyst with progress updates and identified trends.
- Opportunity to publish research-related blog post.
